**GENERAL INFORMATION**

BAM-FX is a liquid ionic (Zn<sup>++</sup> and Cu <sup>++</sup>) micronutrient solution designed for foliar, soil and hydroponic applications for the enhancement of zinc and copper related functions of plants and where zinc and copper are found to be physiologically deficient.

BAM-FX may be used in conjunction with most other liquid fertilizers, pesticides and adjuvants. Consult technical representative for proper rates and compatible combinations. For unfamiliar mixes, jar test or test spray a small area prior to commercial application.

**PRECAUTIONS**

Tank Mix: When handling tank-mix material wear gloves and appropriate eye protection. Thoroughly flush all equipment with clean water after application. Read the entire BAM-FX label prior to mixing and application and follow Directions for Use.

NOTE: Technical BAM-FX concentrate may be incompatible with carbon steel, aluminum and galvanized steel and should be stored and/or shipped in fiberglass or HDPE polypropylene plastic containers. Causes eye irritation. When handling concentrate material wear gloves and eye protection. If eye exposure occurs, rinse

### **STORAGE**

BAM-FX should be stored in dry, protected locations. Use only high-density polyethylene (HDPE) plastic containers with caps that seal to prevent product leakage or accidental container damage during storage.

**CONTAINER DISPOSAL:** Do not reuse container. Dispose of containers by triple rinsing and offering for recycling or discarding in accordance with local, state, and federal regulations.

### **DIRECTIONS FOR USE**

#### **TREES, VINES & BERRIES:**

For foliar applications apply BAM-FX at 4-32 oz. per acre (0.25 to 2.5 l/ha). Use near bloom, throughout the growing season and during periods of physiological stress. Apply in a water volume of 15-200 gallons per acre.

For soil applications apply 8-64 oz. per acre periodically throughout the growing season with standard application methods, including fertigation, top dress, soil drench and with blended fertilizers

#### **VEGETABLE & FIELD CROPS:**

For foliar applications apply BAM-FX at 4-32 oz. per acre (0.25 to 2.5 l/ha) in a water volume of 2.5-100 gallons per acre. Use lower rates for cotyledon 3-4 true leaves (dicots) and first leaf to 3-4 leaf stage (monocots) and higher rates as the biomass increases.

For soil application apply 16-64 oz. per acre with standard application methods including with blended fertilizers.

**HYDROPONICS:** Use at a rate of 0.07 ppm.

**IMPORTANT NOTE:** Use only clean, plastic or stainless steel spray tanks and nozzles to maintain the active electrical charge of the product.
